Written proof of purchase, purchase date, and possession of original product labels by the claimant is a condition precedent to any warranty coverage. **This Limited Warranty does not include or cover, and specifically excludes, any costs, damages or expenses associated with the repair or replacement of the defective product, or damage to or loss of use of any product, building component, property or profit. Other limitations and exclusions apply as noted below.**
